

# Key Investor Information

## OBJECTIVES AND INVESTMENT POLICY

### Investment Objective

To generate growth over the longer term (5 years or more) by investing in European smaller capitalisation equities (company shares).

**Performance Target:** To achieve a return in excess of the FTSE Developed Europe Small Cap Index over rolling five year periods (after charges). There is no certainty or promise that the Performance Target will be achieved.

**Performance Comparator:** The Investment Association European Smaller Companies Equity Sector Average.

The FTSE Developed Europe Small Cap Index (the "Index") is a representative index of the stock market for European smaller companies.

The Investment Association European Smaller Companies Equity Sector Average (the "Sector") is a representative group of investment funds with a focus on European Smaller Company equities.

### Investment Policy

#### Portfolio Securities

- The fund will invest at least 70% in equities of European (including UK) smaller companies.
- European smaller companies are defined as any company of a size similar to those in the Index.
- The fund may also invest in larger European companies.
- The fund may also invest in other funds (including those managed by Aberdeen Investments), cash and assets that can be turned into cash quickly.

#### Management Process

- The management team use their discretion (active management) to maintain a diverse asset mix at country, sector and company level.
- Their primary focus is on company selection using the management team's quality,

growth and momentum approach. It aims to identify companies that exhibit a range of high quality characteristics, have the ability to deliver sustained long term growth and are displaying positive growth in their earnings.

- Due to the active nature of the management process, the fund's performance profile may deviate significantly from that of the Index.  
Please note: The fund's ability to buy and sell smaller companies and the associated costs can be affected during periods of market stress. In certain circumstances investors in the fund may not be able to sell their investment when they want to.

#### Derivatives and Techniques

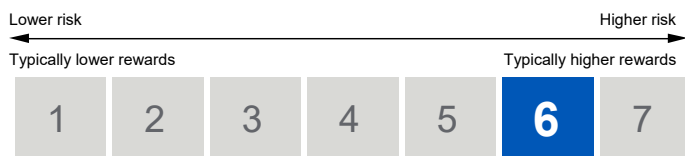
- Derivatives are linked to the value of other assets. In other words, they derive their price from one or more underlying asset.
- Derivative usage in the fund is expected to be very limited. Where derivatives are used, this would mainly be in response to significant inflows into the fund so that in these instances, cash can be invested while maintaining the fund's existing allocations to equities.

Investors in the fund may buy and sell shares on any dealing day (as defined in the Prospectus).

If you invest in income shares, income from investments in the fund will be paid out to you. If you invest in accumulation shares, income will be added to the value of your shares.

**Recommendation:** the Fund may not be appropriate for investors who plan to withdraw their money within five years. Investors should satisfy themselves that their attitude to risk aligns with the risk profile of this fund before investing.

## RISK AND REWARD PROFILE



This indicator reflects the volatility of the fund's share price over the last five years which in turn reflects the volatility of the underlying assets in which the fund invests. Historical data may not be a reliable indication for the future.

The current rating is not guaranteed and may change if the volatility of the assets in which the fund invests changes. The lowest rating does not mean risk free.

The fund is rated as 6 because of the extent to which the following risk factors apply:

- The fund invests in equity and equity related securities. These are sensitive to variations in the stock markets which can be volatile and change substantially in short periods of time.
- The shares of small and mid-cap companies may be less liquid and more volatile than those of larger companies.
- Derivatives Risk - The use of derivatives may involve additional liquidity,

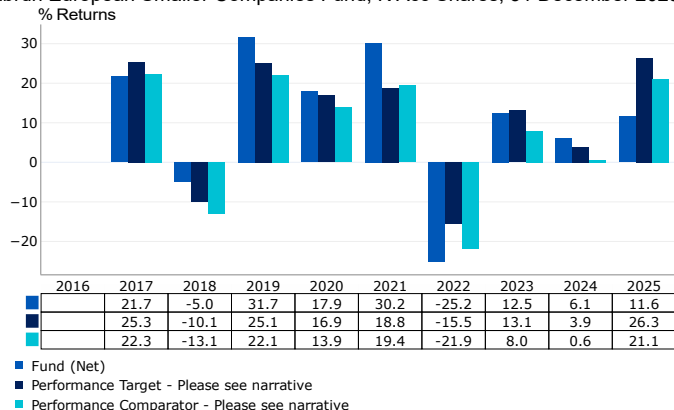
