

# Key Investor Information

## OBJECTIVES AND INVESTMENT POLICY

### Investment Objective

To generate growth over the long term (5 years or more) by investing in European equities (company shares).

**Performance Target:** To achieve a return in excess of the FTSE World Europe ex UK Index over rolling five year periods (after charges). There is no certainty or promise that the Performance Target will be achieved.

**Performance Comparator:** The Investment Association Europe excluding UK Equity Sector Average.

The FTSE World Europe ex UK Index (the "Index") is a representative index of the European (excluding UK) stock market.

The Investment Association Europe excluding UK Equity Sector Average (the "Sector") is a representative group of investment funds with a focus on European (excluding UK) equities.

### Investment Policy

#### Portfolio Securities

- The fund will invest at least 70% in European (excluding UK) equities.
- The fund may also invest in other funds (including those managed by Aberdeen Investments), cash and assets that can be turned into cash quickly.

#### Management Process

- The management team use their discretion (active management) to maintain a diverse asset mix at country, sector and company level.
- Their primary focus is on selecting companies using research techniques to select individual holdings. The research process is focused on finding high quality companies that can be held for the long term through the assessment of their

business model, the industry they operate in, their financial strength and the capability of their management team.

- Due to the active nature of the management process, the fund's performance profile may deviate significantly from that of the Index.

#### Derivatives and Techniques

- Derivatives are linked to the value of other assets. In other words, they derive their price from one or more underlying asset.

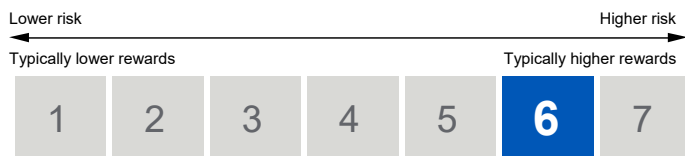
- Derivative usage in the fund is expected to be very limited. Where derivatives are used, this would mainly be in response to significant inflows into the fund so that in these instances, cash can be invested while maintaining the fund's existing allocations to equities.

Investors in the fund may buy and sell shares on any dealing day (as defined in the Prospectus).

If you invest in income shares, income from investments in the fund will be paid out to you. If you invest in accumulation shares, income will be added to the value of your shares.

**Recommendation:** the Fund may not be appropriate for investors who plan to withdraw their money within five years. Investors should satisfy themselves that their attitude to risk aligns with the risk profile of this fund before investing.

## RISK AND REWARD PROFILE



This indicator reflects the volatility of the fund's share price over the last five years which in turn reflects the volatility of the underlying assets in which the fund invests. Historical data may not be a reliable indication for the future.

The current rating is not guaranteed and may change if the volatility of the assets in which the fund invests changes. The lowest rating does not mean risk free.

The fund is rated as 6 because of the extent to which the following risk factors apply:

- **Equity Risk** - The fund invests in equity and equity related securities. These are sensitive to variations in the stock markets which can be volatile and change substantially in short periods of time.
- **Derivatives Risk** - The use of derivatives may involve additional liquidity, credit and counterparty risks. In some cases the risk of loss from derivatives

may be increased where a small change in the value of the underlying investment may have a larger impact on the value of the derivative.

The annual report for each financial year will include detail on the exact charges made.

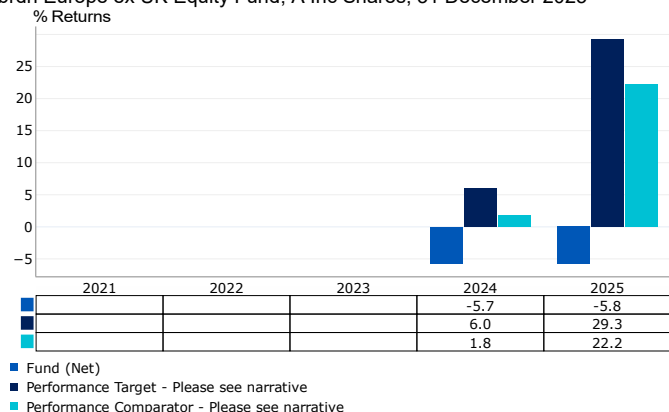
