## OBJECTIVES AND INVESTMENT POLICY

### Investment Objective

To generate growth over the long term (5 years or more) by investing in global equities (company shares).

Performance Target: To achieve a return in excess of the MSCI World Index over rolling five year periods (after charges). There is no certainty or promise that the Performance Target will be achieved.

The MSCI World Index (the "Index") is a representative index of world stock markets.

### Investment Policy

#### Portfolio Securities

- The fund will invest at least 70% in global equities that make up the Index.
- The fund may also invest in other funds (including those managed by Aberdeen Investments), cash and assets that can be turned into cash quickly, and to a small extent equities which do not make up the Index.

#### Management Process

- The management team seek to enhance the level of return that can be achieved for a level of risk similar to that of the Index.
- The management team assess companies from the Index using numerical techniques to build a portfolio with increased exposure to companies expected to generate a higher return in comparison to the Index, whilst maintaining a similar risk

profile to that of the Index.

- Due to the nature of the management process, the fund's performance profile is not expected to deviate significantly from that of the Index over the long term.

#### Derivatives and Techniques

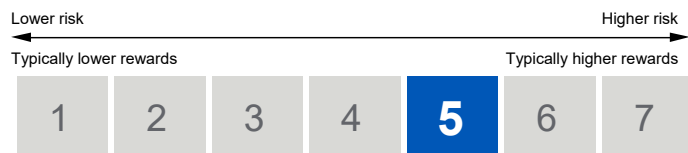
- Derivatives are linked to the value of other assets. In other words, they derive their price from one or more underlying asset.
- Where derivatives are used, this would typically be to maintain allocations to equities while meeting cash inflows or outflows. Where these are large relative to the size of the fund, derivative usage may be significant for limited periods of time.

Investors in the fund may buy and sell shares on any dealing day (as defined in the Prospectus).

If you invest in income shares, income from investments in the fund will be paid out to you. If you invest in accumulation shares, income will be added to the value of your shares.

Recommendation: the Fund may not be appropriate for investors who plan to withdraw their money within five years. Investors should satisfy themselves that their attitude to risk aligns with the risk profile of this fund before investing.

## RISK AND REWARD PROFILE



This indicator reflects the volatility of the fund's share price over the last five years which in turn reflects the volatility of the underlying assets in which the fund invests. Historical data may not be a reliable indication for the future.

The current rating is not guaranteed and may change if the volatility of the assets in which the fund invests changes. The lowest rating does not mean risk free.

The fund is rated as 5 because of the extent to which the following risk factors apply:

- The fund invests in equity and equity related securities. These are sensitive to variations in the stock markets which can be volatile and change substantially in short periods of time.
- The fund may invest in companies with Variable Interest Entity (VIE) structures in order to gain exposure to industries with foreign ownership restrictions. There is a risk that investments in these structures may be adversely affected by changes in the legal and regulatory framework.

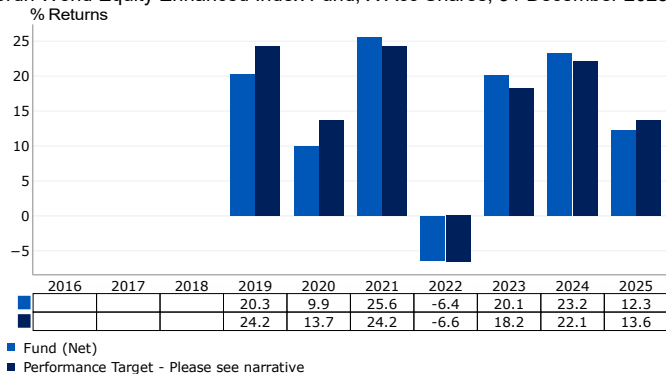
