## WHAT IS THIS PRODUCT?

**Type:** Shares in a Variable Capital Company authorised as a UCITS

**Term:** This product is not subject to any fixed term. The board of the Company may terminate the product unilaterally in the circumstances set out in the Prospectus.

**Objective:** The Fund aims to achieve growth on your investment.

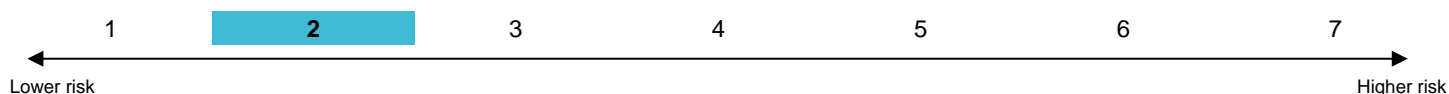
**Policy:** The Fund invests at least 70% of its assets in fixed income securities (investments which provide a certain level of income or interest) issued mainly by governments, government like organisations and other issuers in Asia or whose primary business is in Asia. The Fund may invest more than 30% of its assets in debt securities in any one or more emerging markets in Asia and any industry. However, the Fund may only invest less than 30% of its assets in offshore debt securities denominated in Chinese renminbi. The Fund will invest at least 70% of its assets in investment grade (seen as being higher quality) fixed income securities. The Fund may also invest in fixed income securities with low or no credit rating. The Fund may invest up to 100% of its assets in emerging markets in Asia, and in any industry. Emerging markets are countries that are progressing toward becoming advanced, usually shown by some development in financial markets, the existence of some form of stock exchange and a regulatory body. The investments in the Fund will be mainly denominated in US Dollars and other major currencies. The Fund's performance is compared against the value of the J.P. Morgan JACI Investment Grade Index. The Fund is actively managed meaning that the Investment Manager uses expertise to pick investments rather than tracking a benchmark. A majority of the Fund's assets could be components of the benchmark. Investment of the Fund's assets is not constrained by the benchmark composition and the Investment Manager has discretion within the Fund's investment policy to invest in assets without regard to the benchmark. The Fund may use derivatives for efficient portfolio management purposes (i.e. to reduce risk or costs, hedge or to generate additional capital and income) with a level of risk that is consistent with the risk profile of the Fund. 5 years has been chosen as the Fund should be considered as a long term investment given its objective. You can buy and sell shares in the Fund on any dealing day. A dealing day is generally defined as a day on which Irish banks and, if applicable, the relevant stock exchange(s) are open for business. Exceptions are noted on the FSI website. As long as we receive your instruction before 10 am (Irish time) on a dealing day, shares will be bought and sold at that day's price. You may receive less than expected if you sell your shares earlier than the recommended holding period. You may receive a regular income from your investment which will be paid monthly. Monthly distributions may be paid from capital which would erode capital and may erode future capital growth potential.

**Intended retail investor:** This product is compatible with retail investors who are seeking growth and income over the long term and who have a basic level of knowledge and/or experience and are able to bear the loss of their investment.

This document describes the Fund, which is a sub-fund of the Company. The Company is an umbrella fund authorised as a UCITS with multiple sub-funds and segregated liability between them under Irish law, which seeks to prevent cross liability between sub-funds. The Company appointed the Manager as its UCITS management company. Investors may request but do not have an automatic right to exchange an investment in the Fund for an investment in another class of the Fund or sub-fund of the Company. The depositary of the Company is Northern Trust Fiduciary Services (Ireland) Limited. The Prospectus, Fund supplements and annual and semi-annual reports are prepared for the Company as a whole and contain information about all of the sub-funds and share classes of the Company and are available free of charge in English, (the Prospectus and Fund supplements are also available in German) on firstsentierinvestors.com or by contacting First Sentier Investors Global Umbrella Fund plc - 2nd Floor, Block A, City East Plaza, Towleron, Ballysimon, Limerick, V94 X2N9, Ireland. Whilst the Company has exercised its UCITS marketing passport rights in certain countries, please note that not all sub-funds and share classes may be registered for distribution in your jurisdiction. ## WHAT ARE THE RISKS AND WHAT COULD I GET IN RETURN?

### Risk indicator



The risk indicator assumes you keep the product for 5 Years. The actual risk can vary significantly if you cash in at an early stage and you may get back less. Please note that even investments in the lowest risk class can lose money and that in extremely adverse market conditions investors should be willing to accept severe losses. You may not be able to sell your product easily or you may have to sell at a price that significantly impacts on how much you get back.

The summary risk indicator ("SRI") is a guide to the level of risk of this product compared to other products. It shows how likely it is that the product will lose money because of movements in the markets or because we are not able to pay you. ## WHAT HAPPENS IF FIRST SENTIER INVESTORS (IRELAND) LIMITED IS UNABLE TO PAY OUT?

You could lose some or all of your investment due to a default of the Fund, the Company's or the Manager's appointed service providers. The Fund's investments are held by the Depository or a third party custodian for safekeeping, which means that in case of a default or a loss of financial instrument belonging to the Fund which is not recoverable, you might not be able to get back the current value of your investment. The Company is also an umbrella fund with segregated liability and, under Irish law, there generally will not be the potential for cross liability between the Funds. Notwithstanding the foregoing, there can be no assurance that, should an action be brought against the Company or the Fund in the courts of another jurisdiction, the segregated nature of the Funds would necessarily be upheld. A default by the Fund, the Company's or the Manager's appointed service providers would not be covered by an investor compensation scheme in Ireland.

## WHAT ARE THE COSTS?

### Costs over Time

The tables show the amounts that are taken from your investment to cover different types of costs. These amounts depend on how much you invest, how long you hold the product and how well the product does. The amounts shown here are illustrations based on an example investment amount and different possible investment periods.

We have assumed:

- In the first year you would get back the amount that you invested (0 % annual return). For the other holding periods we have assumed the product performs as shown in the moderate scenario. Please be aware that these are only assumptions for the purposes of illustrating the costs.

- CNH 10,000 is invested.
