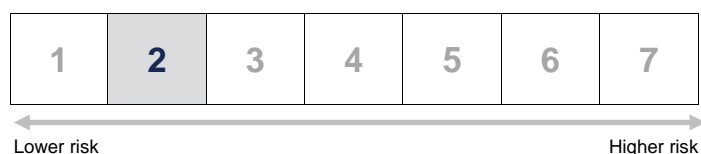

### WHAT IS THIS PRODUCT?

<b>Type:</b>	An umbrella fund constituted as an investment company with variable capital under the laws of Ireland
<b>Term:</b>	The Fund does not have a targeted closure date and may be liquidated at any time, as further detailed in the Prospectus
<b>Objectives:</b>	<p>To seek to provide investors with attractive current income that is consistent with preservation of capital.</p> <p><b>Investment Policy:</b> The Fund will navigate multiple sectors, including low and high grade investment grade income, as well as an increased allocation to high yield, depending on market conditions and attractiveness to generate income. The Fund will invest at least 50% of its Net Asset Value in assets which exhibit positive or improving environmental ("E") and/or social ("S") characteristics.</p> <p>The Fund will invest primarily in an actively managed diversified portfolio of investment grade fixed income instruments which are listed or traded on Recognised Markets. The Fund may invest in the above instruments subject to the following limits: (i) the Fund will invest no more than 35% of its Net Asset Value in below investment grade instruments; and (ii) the Fund is permitted to invest to a lesser extent in other types of debt instruments such as certain loan instruments (which may be securitised or unsecuritised) which qualify as money market instruments in accordance with the requirements of the Central Bank, collateralized loan obligations ("CLOs"), convertible bonds, including CoCos. Investment in each type of such debt instruments may not exceed 10% of the Fund's Net Asset Value respectively and they are not expected to be materially leveraged. The Fund may also invest in units and/or shares in collective investment schemes (subject to a limit of 10% of the Fund's Net Asset Value) where such investment is consistent with the investment objective of the Fund.</p> <p>The fixed income instruments in which the Fund invests may include instruments issued by governments, corporations, and supranational entities. The fixed income instruments shall include bonds, notes, debentures, treasury obligations, sovereign issues, covered bonds, commercial paper, certificates of deposit, banker acceptances and other fixed and floating rate income securities.</p> <p><b>Share Class Currency Hedging:</b> This Share Class is not hedged.</p> <p><b>Distribution Policy:</b> Income will be declared and distributed as a dividend quarterly.</p> <p><b>Dealing Frequency:</b> Daily. Investors can buy and sell their shares on demand on each Business Day (as defined in the Prospectus).</p> <p><b>Benchmark:</b> 'Bloomberg Global Aggregate Bond Index'. The Fund is actively managed and is not designed to track the Benchmark so its performance may deviate materially from the Benchmark. The investment manager has complete discretion in making investments and is not constrained by the Benchmark. The Fund may invest significantly in instruments which are not included in the Benchmark. The Benchmark is used only for risk management and performance comparison purposes. The investment manager may consider, for example, issuer exposures, duration, sector weights, country weights, credit ratings and tracking error in each case relative to the Benchmark but does not use the Benchmark as an investment limitation.</p>
<b>Intended Retail Investor:</b>	The Fund is intended for all investors seeking attractive current income that is consistent with preservation of capital. Investors should have the ability to bear losses up to the amount they have invested in the Fund. The Fund does not offer capital protection.

<b>Further Information:</b>	The Fund is a sub-fund of Barings Umbrella Fund plc, which is an investment company with variable capital with segregated liability between sub-funds, and investors may exchange their Shares in the Fund for Shares in other sub-funds of the Company. ## WHAT ARE THE RISKS AND WHAT COULD I GET IN RETURN?

### Risk indicator

## WHAT HAPPENS IF BARING INTERNATIONAL FUND MANAGERS (IRELAND) LIMITED IS UNABLE TO PAY OUT?

The assets of the Fund are segregated from those of Baring International Fund Managers (Ireland) Limited. The Depositary is responsible for the safekeeping of the Fund's assets. To that effect, if Baring International Fund Managers (Ireland) Limited defaults, there will be no direct financial impact on the Fund. In addition, the Fund's assets shall be segregated from the Depositary's assets, which limits the risk of the Fund suffering some loss in case of default of the Depositary. You may face a financial loss if your broker or the entity from whom you purchased the Fund was to default.

As an investor in the Fund, there is no compensation or guarantee scheme in place.
