What is this product?

Type

Short Duration Sterling Fund (the "Fund") is a Sterling denominated sub-fund of a SICAV (société d'investissement à capital variable), abrdn Liquidity Fund (Lux), incorporated in Luxembourg.

Term

abrdn Liquidity Fund (Lux) (the "Company") has no maturity date. The Fund and the Company may not be unilaterally terminated by abrdn Investments Luxembourg S.A.

Objective

The Fund aims to achieve income by investing in investment grade debt, debt-related securities and Money Markets Instruments whilst aiming to avoid loss of capital. The Fund aims to outperform FTSE UK Sterling Eurodeposit 1 Month.

Portfolio Securities

- The Fund invests mainly in Money Market instruments and bonds (which are like loans that pay a fixed or variable rate of interest) denominated in Sterling.
- The Fund invests in a wide spectrum of fixed and floating sterling denominated debt and debt-related instruments and Money Market Instruments including but not limited to bonds, debentures, commercial paper, floating rate notes, certificates of deposit and Asset Backed Securities.
- The Fund may invest up to 20% in Asset Back Securities of its net assets and up to 10% of its net assets in other collective investment schemes, including those which are managed, directly or indirectly, by the Investment Manager or its affiliates. The Board may decide to increase the investment limit in Asset Backed Securities to up to 50%. Such decision will be notified to Shareholders in the Fund at least twenty-four (24) hours in advance.

Management Process

- The Fund is actively managed and is not constrained by a benchmark.
- Our investment team will seek to obtain and maintain an AAA or equivalent credit rating assigned by at least one ratings agency.
- The maximum duration of the Fund's investments will not exceed 1 year with the maximum expected maturity of instruments up to 5 years.
- The Fund does not qualify as a Money Market Fund under the Money Market Funds Regulation (EU) 2017/1131 (MMF Regulation).
- abrdn integrate environmental, social and governance (ESG) considerations within the investment process. A comprehensive analysis of ESG factors is therefore performed at the credit quality assessment stage of the investment process. Derivatives and Techniques

- Derivatives will only be used for hedging or to provide exposures that could be achieved through investment in the assets in which the Fund is primarily invested. Usage of Derivatives is monitored to ensure that the Fund is not exposed to excessive or unintended risks. the Fund may use other investment techniques to enhance the value of the Fund, including transactions that relate to the sale and repurchase of an asset (known as 'reverse repos') over a short period of time.

This fund is subject to Article 6 of the Sustainable Finance Disclosure Regulation ("SFDR").

Investors in the fund may buy and sell shares on any dealing day (as defined in the Prospectus). If you invest in income shares, income from investments in the fund will be paid out to you. If you invest in accumulation shares, income will be added to the value of your shares.

Intended Retail Investor

Investors with basic investment knowledge. Investors wanting to preserve capital. Investors wanting an income and to preserve capital over the short term (less than 1 year). The Fund has specific and generic risks with a risk rating as per the risk indicator. The Fund is intended for general sale to retail and professional investors through all distribution channels with or without professional advice.
